

SCHOOL LETTINGS IN MANY DISTRICTS

INSTRUCTORS CHOSEN IN NEARLY ALL COUNTY SCHOOLS

Provisional and Professional Certificates Issued to 242—158 Failed at Examinations—Choice of the Directors in Many Districts in the County—A Few Vacancies to Be Filled.

Including the special examination which was held here on Saturday by County Superintendent James F. Chapman exactly 400 prospective teachers were examined in the county for provisional and professional certificates, and of this number 242 passed a satisfactory examination.

With few exceptions all the school boards of the county have already elected their full quota of teachers. In a few districts there are some vacancies to fill but there is no likelihood of difficulty in securing instructors for these schools.

The Progress published last week the list of teachers chosen by the various boards over the county which had held their lettings, but the greater number of instructors were elected during the latter part of last week and in this week's issue, the names of the lucky applicants in the remaining districts are published.

NORMAL LEASES C. R. SMITH HOME ON RAILROAD AVENUE. Building Will Accommodate Two Teachers and 20 Students.

At a meeting of the Board of Trustees of the Normal school held on Friday night, the beautiful home of Clarence R. Smith on Railroad avenue was leased for three years. Workmen begin this week remodeling the stable on the property and dividing it up into rooms suitable for students. When completed the two buildings will accommodate two teachers and 40 students.

With the acquisition of the Smith property the school will not release the St. Clair and McCartney flats. The new property is just across the railroad from the Normal campus and is ideal for the purpose for which it was secured.

Mr. Smith will erect a smaller home on a portion of the lot for his own use.

Clymer Plant Resumes Operations. After an idleness of several months the plant of the Clymer Manufacturing Company on West Philadelphia street resumed operations under a new management on Monday.

BIG MORTGAGE FILED.

New York Central and B. & P. interests Striving for Local Coal Fields. There is a lively struggle on between New York Central and Buffalo, Rochester & Pittsburg interests for the possession of Indiana county's unsoiled coal lands. The recent acquisition of a large field in Center and Blacklick townships by the New York Central had added zest to the rivalry. The latest move of the B. & P. interests is the filing of a mortgage of more than \$2,000,000 on the Jefferson & Clearfield Company's holdings in Armstrong and surrounding townships. The document covers about 15,000 acres of double and other property of value throughout the face of the mortgage. The funds derived from the mortgage will be used to secure additional coal holdings and representatives of the B. & P. interests are already reaching out for new territory.

Mrs. Nancy Weaver died at her home near Flora, July 19, 1910, aged 76 years, two months and eighteen days. She was born April 23, 1834, in Backlick. Her father, Finley Cameron, was born in Scotland, and her mother, Amelia Neff, was born in Indiana county. On May 29, 1855, she was married to William Weaver, who preceded her by the other world many years ago. Three sons and five daughters survive to mourn the loss, namely: Thos. HEAVY DAMAGE DONE BY STORM SATURDAY

RAIN, WIND AND LIGHTNING PROVE DESTRUCTIVE

Barn Struck and Destroyed Near Parkwood—Crops Damaged by the High Waters and Several Small Bridges Were Washed Away—Homer City Man a Heavy Loser—Telephone and Telegraph Service Was Crippled—Stock and Chickens Drowned.

Damage amounting to several thousand dollars was committed by the severe rain and electrical storm that visited the county on Saturday afternoon. Several buildings were struck by lightning, one was destroyed. Crops were damaged by the high waters, a number of small bridges were washed away and telephone and telegraph service on all local lines were crippled by wind and lightning.

The storm was extremely local. While considerable rain fell in Indiana Saturday afternoon, there was none three miles north of town until late Saturday night.

During the electrical storm on Saturday afternoon the barn on the E. Thomas Caldwell farm, near West Lebanon was struck by lightning and burned to the ground. The farm was recently purchased by Wilson Wiggins, but was occupied by John Caldwell, who suffered considerable loss. He had a slight insurance.

The flood in Yellow creek and damage amounting to \$500 to property of Joe Mazza on Saturday. Mr. Mazza recently built several houses north of Homer City, across Yellow Creek. He had just completed a wooden bridge of five spans across Yellow creek when the flood came. The first rush of water carried away all but one span of the bridge and washed away timber valued at \$500.

A bridge crossing Stony run, near Herbert Brown's in White township, was carried away and corn and grain fields in that section were damaged. Two small bridges crossing Curry Run, near Peelor's Mill in Armstrong township, were washed away and the crops in that section were badly damaged on Saturday.

A valuable cow belonging to C. F. Ling of East Wheelfield township, was killed by lightning during the storm on Saturday evening. The barn of R. G. Mack in the same township was struck by an electric bolt but no damage resulted. William Crissman, of White township, had 42 chickens drowned and a wagon carried away by the high waters.

The grounds at the Country Club on Twolick creek were considerably damaged, the road to the clubhouse being so badly washed that it is impassable. Lightning struck the house on the fair grounds occupied by Thomas Fleming, Frank Grimm, who had just returned from work, and Mrs. Fleming, who was in the house when it was struck. Other buildings struck were the house on the James Campbell farm, south of Indiana, occupied by a Mr. Layton, and the Thos. Lowman property on North Ninth street. No one was injured at either place.

Standing waist deep in water a tel. phone lineman had to cut barbed wire before the vehicle in which he was riding could cross the bridge over Cherry run, in Center township, on Saturday evening. Columbus McCoy, of town, was driving a hack carrying a crew of telephone construction men. In crossing the Cherry run bridge they discovered barbed wire from a fence had been washed across the structure. The team became entangled in the wire and one of the linemen had to cut it under water to free the horses.

The dynamo at the Lucerne coal works, near Homer City was struck by lightning one day last week and the machine was so badly crippled that operations had to be suspended for three days. The water was two feet deep on the road in front of the home of E. E. Johns, of Center township. Mr. Jobe's spring house was flooded and its contents wrecked. Several acres of grain belonging to T. P. Stephens in Center township, were washed away.

BOY HAD NARROW ESCAPE IN HIGH WATERS SATURDAY

Was Thrown from Horse Into Deep Water and Rescued by Father. Jay McCoy, son of Bert McCoy, of Center township, had a narrow escape from drowning in the high waters of Cherry Run caused by Saturday afternoon's heavy storm. Following the storm that evening Mr. McCoy and his son went after the cows on horseback. The horse ridden by Jay stepped off the bridge crossing Cherry run, near their home, and the boy was thrown into six feet of water. The current was swift and the young man was carried several yards before he rose to the surface. Mr. McCoy drove his horse into the water, but accidentally slipped off the animal's back and father and son were both struggling in the water. Mr. McCoy again to the horse and remounting it again, urged the animal to swim in the direction of the boy, who was being carried down stream rapidly. The horse finally overtook the boy more than 300 feet from where he had fallen into the water and Mr. McCoy rescued him with both the father and son on his back.
